OUTDOOR BURNING LETTER PERMITS: 03/01/2021 to 03/31/2021

There were two Outdoor Burning Letter Permits (OBLPs) issued in March, both for forest slash debris.

1. Issued Special Letter Permit 20B21-03-01 on March 11 to Willamalane (Fraser MacDonald), 18020200 Lots 00401; 00400, Springfield, to burn 87 cubic yards of Forest Slash debris located at 18020200 Lots 00401; 00400 - Thurston Hills, See attached Map.

2. Issued Special Letter Permit 20B21-03-02 on March 11 to Mt. Pisgah/FOBP (Jason Blazar), PO Box 5266, Eugene, to burn 500 cubic yards of Forest Slash debris located at Mt. Pisgah/Buford Park, See Attached Maps.

ASBESTOS ABATEMENT: 03/01/2021 to 03/31/2021

During March, LRAPA received 38 notices of asbestos removal projects, 2 of which were schools (Twin Oaks Elementary School and Sheldon High School).

On-Going

A significant portion of Public Affairs time in March was focus on LRAPA's 2020 annual report which is now finalized and published. The report, when posted to our website, was sent to LRAPA's Board of Directors and Citizens Advisory Committee. Those who have subscribed to LRAPA's email notification list were also sent a link to the report. It can be found on our website here:

Public Affairs staff continue to work with the Oregon Department of Environmental Quality (DEQ), Oregon Health Authority (OHA), local community members, and others to engage the community in meaningful ways. To answer and address concerns related elevated levels of dioxins collected in dirt samples along roadways in a neighborhood near J.H. Baxter & Co. The fourth community engagement meeting that involved members of the Bethel Neighborhood took place in on March 3rd. Public Affairs gave an overview presentation on Cleaner Air Oregon. The next upcoming meeting is Wednesday April 7th. LRAPA public affairs plans to discuss our Air Toxic monitoring around J.H. Baxter. These meetings are in preparation of a larger public meeting on J.H. Baxter & Co. in the late spring/early summer of 2021.

LRAPA is hosting and organizing reoccurring meetings with DEQ and OHA to plan and prepare for 2021's Air Quality Awareness Week (May 3-7) public information campaigns. LRAPA is also participating with EPA Region 10, and other regional clean air agencies to coordinate public messaging for Smoke Ready Week, 2021 (June 14-21) in preparation of the upcoming wildfire season. Public Affairs has begun drafting messages during for this social media campaign which will be shared and reviewed by DEQ/OHA in the next planning meeting in early April.

LRAPA Public Affairs continues to work with our partners to administer the Oakridge Air, Targeted Airshed Grant. Public affairs installed two new commercial grade air quality sensors in Oregon. With additional installations on the way. Public Affairs is supporting and planning with Oakridge Air Partners an outdoor public meeting in Oakridge to discuss Oakridge air, Firewise programs, and defensible spaces.






